

Our tropical climate, which will be hot and humid at the end of July, invites you to enjoy the outdoor life year-round. NLS Board Minutes — NLS Teleconference Minutes

Tracy Schmidlin called the September 14, 2008 meeting to order at 7:45 PM.

Present: Tracy Schmidlin, Dave Erdman, Nanette (Nu) Helgager, Pr. Doug Givan, Bob Northrup, Judy Laabs-Foss, Diane Purcell, Pr. Larry Bowman, and Katie Sistar.

We welcomed Pr. Doug Givan and Pr. Larry Bowman to their first conference call with us. Pr. Doug opened with prayer.

Website Coordinator - Larry Bowman: He is still working on connection to the internet. Judy let us know that Bob has posted the newsletter to the website. We will send him the minutes.

Action Items discussed:

Tracy has processed the speaker cards collected at Nationals. She has put together a packet of information for the National Coordinator and sent it to Ed Broestl. He is taking the leadership role and has created a whole plan of action to move forward with it.

Diane stated that the renewal of the domain name was taken care of in the spring, and Bob should be getting information on this soon. Checks were issued for this to be done last spring.

Tracy will be contacting lay directors to touch base with them.

Diane is writing an insurance article and has completed the 501c and insured parts. She would like Fred Snyder to ensure that the wording is correct. She will also send it to Light in the Desert to ensure that things are being stated correctly. She will have it ready at our Mid-Year meeting for the board to review.

The copyright papers are downloaded and ready for the book.

VP Administration Report – Nu Helgager:

Communication with Florida is going well. The use of the rooms at the college will not be settled until May 29. The board can work on

the agenda without room assignments at the Mid-Year meeting. We can put out the detail agenda with locations in June.

Nu is contacting the present lead person from each region to ascertain if they are willing to continue to do that job for the coming year.

She is processing the evaluations from Phoenix, and overall they look good. It was suggested that the evaluation forms be included in the notebook so people could write comments all along. It worked out well to complete the forms and turn them in at Saturday's business meeting. The business meetings were good time-wise.

Florida is working on the registration forms for 2009 Nationals.

Secretary's report – Katie Sistar:

The board discussed adding a short teleconference after the National meeting and the Mid-Year meeting for the board to review the minutes all at one time since for those meetings there are quite a few pages to go over. This would eliminate sending minutes back and forth several times through e-mail for corrections and additions, and it would be more efficient. *Bob Northrup moved that the board add a teleconference after the Annual Meeting and the Mid-Year meeting to review the minutes. Katie Sistar seconded. Motion approved.*

Packets of information from the Annual Meeting were mailed to absent secretariat lay directors in August.

The letterhead is updated.

Katie still needs the reports from Joe Nilsen and the Regions reports to file.

There is a notebook with the original signed constitution and by-laws from 1987, and she will locate the signed revised constitution and by-laws that have been filed. We have a disk with the past minutes and records from 2005 in the secretary's records.

Treasurer – Bob Northrup:

At the Annual Meeting there was

\$4260 in unpaid dues to the National Lutheran Secretariat. He put together a new database with a current list of Treasurers and requested payment. \$3250 was collected. There are four secretariats that still need to pay last year's dues.

Jerry Lemcke will provide paperwork concerning finances from June and July by the November Mid-Year meeting.

The Thrivent account has \$21,084 and the Wachovia account has \$5660 with a total cash balance of \$26,744. He did not have the current balance for the Distribution Center.

Jerry sent the remote deposit machine which will make it possible to make deposits from his home as needed.

The board discussed the \$1000 amount that Florida may need for the Mid-Year meeting. According to the Host documents, after the expenses for the meeting are spent, they can request up to \$1000 to be reimbursed from the board.

VP Outreach – Dave Erdman:

He is beginning to contact the secretariats that weren't at Nationals. Dave brought up that there is a potential new secretariat in Michigan. They want to use the materials and do it with a Lutheran Church Missouri Synod outlook. The board discussed the ramifications of this. We decided to think of questions that the board could ask them to clarify and what needs to be done to be part of the Via de Cristo framework.

There have been feelers from N. Michigan, Utah, and Germany as well. He has sent a copy of the Essentials and the Constitution and By-laws to Oregon and will follow up.

Spiritual Director – Pr. Doug Givan:

He has gone through the folder that John gave him. He would have liked to have had more time to talk with other pastors at the Annual Meeting after he was elected. He

would like a list of Spiritual Directors to get a database of pastors and where they are. He is e-mailing weekly devotions to the board. He hopes to encourage ministers and bishops to be active in VdC.

Newsletter Editor – Judy Laabs-Foss: The newsletter is online now.

Financial Advisor – Diane Purcell: Northern Lights has corporation documents. Arizona called to say that they passed a resolution at Council to tithe 10% of all income from the secretariat to go toward the National Coordinator position.

Old Business:
National Coordinator position – Tracy sent a packet of information to Ed Broestl. The committee is ready to go forward.

The trademark and copyrights are up to date.

Bob is backing up the website.
Pr. Doug plans to work with Carlene Lemcke concerning worship at 2009 Nationals.

Bob found a less expensive company to do our conference calls. *Nu moved that the board change the conference call company from Quest to ACCU Conference Company. Bob seconded. Motion approved.*

Diane asked for prayers for Minnesota. We want to let the convenors know the National Board is supporting them in prayer as they plan for hosting in 2010.

Board discussed the airfare to Miami and Fort Lauderdale and plane schedules. The board decided we needed to arrive at the Fort Lauderdale airport on Thursday, November 6 instead of Friday to be able to get our planning done before flights leave on Sunday, November 9.

Pr. Doug closed with prayer. Meeting closed at 9:35 PM.

Mid year Planning with the FL Host Teams

NLS Board Minutes — Midyear meeting November 7 — 8, 2008

The NLSEB met at Barry University at 9:00 a.m. on Friday, November 7, 2008.

Present: Tracy Schmidlin, Bob Northrup, Judy Laabs-Foss, Nanette (Nu) Helgager, Dave Erdman, Katie Sistar, and Diane Purcell. Pastor Doug Givan arrived at 11:00 a.m.

Tracy opened with prayer. Nu read a devotional that Pr. Doug had sent.

The board reviewed the September 14 Teleconference minutes. *Bob moved that the minutes be approved as amended. Nu seconded. Motion carried.*

Bob presented a Treasurer's report. All but \$500.00 of the delinquent dues has been paid. Two secretariats reported that they were unable to pay at this time. The two groups stated that they could pay a portion of the amount due. *Bob moved that Tennessee VdC's money due for March 2007 be palancaed. Dave seconded. Motion carried. Bob moved that River's Edge dues for 2007 be reduced to \$100.00. Dave seconded. Motion carried. Bob moved that Prairie Sonshine dues for 2007 be palancaed down to the payment of \$100.00. Nu seconded. Motion carried.* Wachovia account has \$4,980; Thrivent has \$21,171; Restricted Funds amount is \$1,437; and Outreach has \$6,515. He received a check from Arizona for \$6,000.00 that has not been deposited yet.

Tracy brought up the request from Ed Caputo to add his booklet for sale as an NLS resource. Judy provided copies of the book for the board to read. *Nu moved that in light of previous policies regarding the sale of items and resources that are not specific to VdC, the board is declining Ed Caputo's request to include his booklet in our resources. Dave seconded. Motion carried.*

Nu presented the board with printed copies of a chart showing the 2008 NLS evaluations. The board discussed them. A copy of this is to be on file with the minutes.

We discussed possible seminars for July.

The board reviewed the Arizona Host Committee final reports. We agreed that reports need to be in sooner than in the past so they can be gone over far ahead of the next Mid-Year meeting. It was agreed that the final reports are to be sent to the NLS board by September 1 each year. The final financial report is to be sent to the board by September 15. The board will pass on information from the reports that will be useful or helpful in planning future annual meetings.

The board recessed for lunch at 12:10 p.m. The board reconvened at 1:10 p.m.

The board discussed Arizona's financial report and had some questions regarding it. *Nu moved that Tracy Schmidlin be authorized to consult with Arizona about their report. Dave seconded. Motion approved.*

The board reviewed Florida's proposed budget. Bob will discuss it further with the leaders. We want to keep the price affordable for delegates and visitors to attend. *Bob moved that registration for NLS 2009 be set at \$175.00. Nu seconded. Motion approved.*

We looked up the verse for "One in the Son" theme and read John 17:21.

The board discussed possible changes in the daily agenda for the NLS annual meeting. We will add another small group breakout time; look at having the elections earlier on Saturday, and have business meetings earlier in the day to help with announcements and communication.

We discussed the need to have the delegate list from the registrations by July 1 to better plan the seating of the delegates and power point presentation. Any delegates that have not registered by that date will still be seated but will be at the end of the list.

The board recessed for supper at 5:00 p.m. and reconvened at 6:30 p.m.

We discussed mealtimes and the extra effort for the breakfasts being provided in July. It requires extra staff time. We worked out a tenta-

tive schedule for the NLS meeting. It is on file.

We continued the discussion of possible topics for the seminars and forum. There needs to be an emphasis on what we can do in our fourth day to better enrich the lives of ourselves and the people in our communities.

Tracy informed us that Joe Nilsen has written a novel entitled Lost and Found. The board expressed gratitude that he has stated that the proceeds are to be donated to the National Coordinator campaign fund.

Pastor Doug led us in prayer. The meeting recessed at 9:00 p.m.

The board reconvened on Saturday at 8:00 a.m. Pastor Doug led us in prayer. Tracy recapped the suggested seminars and the forum suggestions. We discussed descriptions and titles for them. Leaders and speakers will be asked to provide a list of resources regarding their handouts. We need to update our DVD and resources in the NLS library.

Nu presented the tentative registration and travel forms from Florida. The board discussed changes.

The board listed the forum and seminars to present in our combined meeting this afternoon. Forum – Spiritual Direction – What's stirring in you?

The seminars will include the following:

1. The Training Panel
2. Growth – the Big Picture
3. Focus – the Fourth Day
4. Corporate Nuts and Bolts – Benefits and Necessities of 501(c)(3).

The board recessed for lunch. The Host Committee for NLSAM 2009 and the NLSEB met together at 1:30 p.m.

Dave Rankin greeted us. Pastor Tom Slager gave a message using John 17:21 as the scripture verse. We celebrated communion.

Nu asked everyone to introduce themselves. All have been very involved in their fourth day. Some have been in reunion groups for over 20 years with the same peo-

ple.

Tracy read "Hosting Is Honorable Serving." Then the Host Committee broke into small groups according to committees and met with board members for questions and discussion of things needed to prepare for the National weekend.

Tracy closed with prayer at 3:45 p.m. The board reconvened at 4:00 p.m.

We discussed ways to advertise funding for the National Coordinator position.

Nu reported that the transportation form will have a place for people to indicate their need for on site transportation. Posters will be in a convenient place to make them easier to get to and sign. The banners will be hung in that room.

Chip Spears showed us the blue and green T-shirts they will be selling at the annual meeting.

Tracy has received the corporate book with all the national corporate documents. The corporate book will remain with the office of president.

The resolutions that we are reviewing were discussed at NLSAM 2008. We continued discussion on copyrighting all NLS documents and the NLS Secretariat Trademark and Logo policy. *Bob moved that we copyright all NLS documents. Dave seconded. Motion carried.*

The copyright policy that was adopted November 8, 2008 states: National Lutheran Secretariat will copyright all original documents and publish all said materials with the appropriate copyright notation, ©. National Lutheran Secretariat will register the copyrighted documents with the United States Copyright office.

In 2010 we will need to reregister the NLS trademark for an additional 10 years. *Bob moved that we adopt the Trademark and Logo Policy. Nu seconded. Motion carried.*

The following is the policy that was adopted on November 8, 2008.

National Lutheran Secretariat has registered "Via de Cristo" with the United States Patent and Trademark Office and has been issued

Reg. No. 2372407.

National Lutheran Secretariat has registered the NLS logo with the United States Patent and Trademark Office and has been issued Reg. No. 2374744.

Use of the "Via de Cristo" name and the NLS logo is strictly prohibited without the expressed written consent of the National Lutheran Secretariat Executive Board.

National Lutheran Secretariat requires the use of the copyright symbol © whenever the copyrighted name "Via de Cristo" is used in a document by an outside source.

National Lutheran Secretariat has registered the name and logo in order to protect the use of name and logo. National Lutheran Secretariat will pursue remedy of unauthorized use of its name and logo.

We continued discussing the vendor's policy. *Bob moved that we adopt the following policy. Nu seconded. Motion carried.*

The Vendor Policy that was adopted on November 8, 2008 is the following:

Outside vendors who wish to sell Christian based items at the National Lutheran Secretariat Annual Meeting must be approved by the National Lutheran Secretariat Executive Board no later than June 1st prior to the Annual Meeting. The National Lutheran Secretariat Executive Board expects that the Host Committee will benefit financially from the vendors. The Host Committee may decide the method to be used – i.e. table charge, percentage of sales, etc.

Symbols, Inc. as provider for National Lutheran Secretariat and other 4th day community crosses is grandfathered in under this policy and is not subject to the Host Committee Vendor Policy. Symbols, Inc. is an approved vendor for all National Lutheran Secretariat Annual Meetings.

Joe Nilsen, who has dedicated the profits from his book to the National Lutheran Secretariat Endowment Fund is grandfathered in under this policy and is not subject to the Host Committee Vendor Policy.

Joe Nilsen is an approved vendor for all National Lutheran Secretariat Annual Meetings.

The Finance Committee recommendations from July NLS 2008 have been discussed, and the board is sending the recommendations back to committee with notations. Bob reported that he plans to send a letter to secretariats with unpaid dues the information that if dues have not been received by May 31, the financial report at NLSAM will show that the secretariat's dues are delinquent.

We will continue to address host committees or other secretariats promoting materials in competition and/or in conflict with NLS copyrighted material.

Board recessed for supper at 6:35 p.m. and reconvened at the hotel at 8:35 p.m.

We discussed the Michigan group that is interested in affiliating with NLS. Dave will be contacting them for further discussions.

We went over the job descriptions in the Constitution and By-Laws and compared them with the printed job descriptions that we have. They are in sync.

The constitution states that the secretary will be in charge of the Corporate Book. We agreed that the secretary should have a copy of it and should designate the president to keep the book since he/she is required to answer more questions related to the documents.

We reviewed a request from Kairos for prayer.

**VIA DE CRISTO IS A RELIGIOUS ORGANIZATION SO WHY DO WE NEED TO TREAT IT LIKE A BUSINESS?!?!**

“Why?” To protect your Secretariat and you and the assets of your Secretariat and your personal assets - both those you have now and those you acquire in the future. This may sound very business-like and a little scary but it is the reality of our litigious world.

A purpose of NLS, according to its Constitution and By-Laws, is to support, strengthen and guide the autonomous secretariats affiliated with it so that the Church may more effectively Christianize its community. This information is being provided to assist Secretariats as they go about the business of Via de Cristo.

NLS strongly encourages **ALL** Secretariats of Via de Cristo to incorporate as a Not-for-Profit corporation, apply for Not for Profit status with the Internal Revenue Service and safeguard the Secretariat by purchasing insurance.

- **INCORPORATE:** When a Secretariat is formed, the group should file incorporation papers with the Secretariat of State of the state in which the Secretariat will conduct business. **If you have not done this, do it now.** Each state has its own Not-for-Profit State Statutes which must be complied with when submitting Articles of Incorporation for recognition and registration as a Not-for-Profit Corporation of the state. The Articles must also contain certain provisions in order to file Form 1023 Application for Recognition of Exemption Under Section 501(c) (3) of the Internal Revenue Code with the Internal Revenue Service.

- By incorporating the Secretariat, a level of protection exists for the individuals who are members of the Secretariat. (The Secretariat’s documents will determine who is a member.) Members are to use due diligence and reasonable care in the performance of their duties and the Secretariat has a duty to protect its members.

- Incorporating is mandatory in order to file with the Internal Revenue Service to be recognized as a Not for Profit organization under Section 501(c) (3) of the Internal Revenue Code.

If a Secretariat chooses to not incorporate, every member of the organization is personally responsible for anything that happens during a Secretariat event. Should a person be injured, claim emotional or physical abuse or any other such claim, all members may be individually sued and be found liable to pay part or all of damages. (Joint and severable liability, which means that one or two people could be made to pay the whole amount.)

- **RECOGNITION of EXEMPTION UNDER SECTION 501(c)(3) of the INTERNAL REVENUE CODE:** Once the Secretariat is incorporated, a federal identification number needs to be obtained from the Internal Revenue Service. This may be done at [www.irs.gov](http://www.irs.gov). Form 1023 Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code needs to be completed and submitted to the IRS. The Form is available on line and may be downloaded to be completed. This application can be a bit overwhelming for some, but assistance is available from NLS to complete and submit the form. The last three applications that the NLS provided assistance with were approved on the first submission. The Secretariat’s Constitution and By-Laws also need to be completed in order to submit with Form 1023.

- The completion of the constitution and by-laws is very important for an organization. These documents comprise the operating structure for the Se-

cretariat.

o Recognition of Exemption as a 501(c)(3) organization solidifies the Secretariat's status as a religious not-for-profit corporation. All donations to the Secretariat are deductible by the donors as a charitable donation on their personal income tax returns. Also, volunteers may also deduct mileage and actual expenses incurred as they serve the Secretariat. (As always, proper documentation should be kept for tax records.)

o Exemption under Section 501(c)(3) exempts the Secretariat from paying income taxes. The Secretariat is required to file an informational return to the IRS on an annual basis. This is required of ALL Secretariats. The correct form to file is determined by a rolling three year average of income.

o If the organization does not file for this exemption, the corporation is considered a for profit entity and is required to file a corporate income tax return and pay income taxes regardless of the income level. Also, no donations are deductible by contributors for income tax purposes.

• **INSURANCE:** Your Secretariat should purchase an insurance policy to protect both your members individually and your Secretariat as an organization. Unfortunately, in our litigious society, our Secretariats need to be good stewards and safeguard the assets of their Secretariat and the personal assets of their members. One Secretariat has already experienced this situation. A person participating on a weekend was injured and sued the Secretariat and all team members. The case has been resolved. Different types of insurance policies are available as well as different ways to obtain insurance coverage. Every Secretariat should work with an insurance agent to be sure you are adequately covered. Policies to be considered are:

- Insurance to protect the Secretariat's physical assets from damage or destruction. One Secretariat experienced a fire in their supply trailer. The trailer and all of the contents were destroyed. The Secretariat was insured.
- Insure to cover personal injury and bodily injury.
- Insurance to cover the Secretariat for expose to lawsuits stemming from allegations of sexual misconduct and molestation. Despite all precautions taken, individuals in our society have committed these types of acts. This insurance does not cover the individuals. The Secretariat is protecting its ministry, innocent volunteers and members.
- Directors and Officers (D&O) insurance to protect the Secretariat's board members against lawsuits. The board is at a greater liability exposure due to their leadership roles. One Secretariat's board has been threatened with a lawsuit but nothing went forward.

In discussion with an insurance agent, the Secretariat can determine what is the best way to protect the Secretariat.

- The insurance policy can be a full policy carried by the Secretariat. Even with a policy, the Secretariat may need to obtain additional riders for specific events.
- The Secretariat may be able to insure the weekend by purchasing a rider on the policy of the rented facility, such as a camp.

These lists are not intended to be all inclusive. Each Secretariat should discuss its insurance needs with a local agent.

This article has been prepared based upon my knowledge of the issues. I am an accountant not a lawyer or an insurance agent. Also, laws regarding not-for-profit corporations of organizations and insurance matters differ by statutes from state to state. The Secretariat needs to be in compliance with state statutes. Hopefully, the Secretariat has resources within its own community to assist with these matters. If not, the Secretariat should obtain legal counsel and/or an insurance agent to be sure that the Secretariat is in compliance with the law and adequately protected.




